

My Affidavit of Standing: In Nomine Dei, Amen.

I AM an AMERICAN CITIZEN by BIRTH and an AMERICAN TRUSTEE IN BANKRUPTCY. I AM protected by the International Treaty, known as the "AMERICAN" DECLARATION OF INDEPENDENCE.
