**Fed Tort Claims Act: Supreme Ct rules 8-0 citizens can hold federal govt liable for abuse by law enforcement officers**

**EMBEZZLEMENT:** A statutory offense, not a common law crime; the **fraudulent appropriation or conversion by an agent**, an employee, a corporate officer, a trustee, a public officer, or other person acting in a **fiduciary capacity** or character, of money or property, the possession of which has been entrusted to him by another. 18 Am J1 st Embez § 2. The word includes misappropriation of Trifling {traffic tickets} sums, made with intent to restore {utilizing 3 year appearance bonds} in due time, and with ample present and prospective ability to restore. {BUT the restoration has never given back to the living individual, the one that the Embezzlement was taken from.} United States v Summers (DC Va) 19 F 627. In statutes imposing a double liability in damages for the "embezzlement" of property of a decedent prior to the granting of letters testamentary or letters of administration, the term means the fraudulent appropriation or concealment to one's own use of estate property in one's possession. Anno: 29 ALR2d 256. *{This has been done by the present Non-Constitutional STATE Courts of Commerce as they setup devoid of Valid Enacting Clauses because the Commerce Courts were to only deal with Interstate Commerce, which was only to be applied to those operating FOR HIRE and/or FOR UNJUST PROFITS using Usury, at the Federal Level, but the STATES instituted Non-Constitutional Commerce Laws that they use to perform their monetary Embezzlements and the Embezzlement of the American Living's Blood of Life with False Arrest and Imprisonments, thereby committing misprisions as a charge of Treason.}*

**EMBEZZLEMENT BY AGENT:** The crime of embezzlement committed by one in possession of the converted or misappropriated property by virtue of his employment by a principal and the delegation of authority to do something in the name and stead of such principal. 26 Am J2d Embez § 26. *{Police Officers, Sheriff's Department, Highway Patrol Officers, Clerks of Court, County and City BAR Attorneys, Commerce Court Judges become CRIMINALS when they Embezzle the property from the living America owner by the usage of Non-Constitutional Laws claiming an injury (be a fraudulent commercial charge in imaginary realm of things) to a fictional person "UNITED STATES" or "STATE OF \_\_\_\_\_". NO REAL HARM – NO FOUL. }*

**EXTORTION.** Oppression under color or right; the criminal offense of obtaining money or other valuable thing by compulsion, actual force, or force of motives applied to the will; more technically defined as the unlawful taking by an officer of the law, by color of his office, of any money or thing of value that is not due to him, or the taking of more than is due, or the taking of money before it is due. Bush v State, 19 Ariz 195, 168 P 508; 31 Am J2d Extort Â§ 1. A method of abuse of process. 1 Am J2d Abuse P Â§ 12.

- 12 And on that night again he reasoned within himself how he could save himself from starvation, and he devised a **SCHEME** how to act.
