I suggest that you read, *'Real Estate or Legal Fiction and Stocks and Blondes: The Corridor to Economic Sovereignty'*.

Now, once again when you hear the word civil your mind is supposed to grasp or get the intimation that there is a relative monetary frequency or premise. Do you overstand what I am saying to you? I pray that you really do.



As one more example of something that transpired just before the civil war, that also instigated it situation in the first place was the **Dred Scott** decision. In a synopsis the **Dred Scott** decision was a ruling made by the Supreme Court that people of **African Descent** were not considered citizens of the **United States** on account to their ancestry despite the fact that Blacks were at least considered free in the **North**.

Well, **Dred Scott** escaped to the **North** and was considered free by northerners however the *cliché* in law was that slaves were considered property while at the same time free if they inhabited the north. The question was a matter of whether or not the perquisite or the prerequisite would be honored in priority to the other.

In terms of the **Dred Scott v. Sanford decision**, slaves were considered chattel or private property of their owners therefore the owners knew that they were entitled to due process in terms of the laws that protect property owners. The courts ruled against the favor of **Dred Scott**.

This decision was never overturned even unto this very day. However, the connotation of the **14th amendment** alludes to the privileges granted to the likes of those that petition to become citizens of this corporation that poses as a country in almost every instance. Yes, you are still considered to be state property and the only thing that has changed since, is the fact that you are property with benefits bestowed upon in the form of privileges. Do you overstand what I am saying to you? I pray that you do.

Now allow us to go back to our original point about civil rights and civil privileges. Your civil rights leaders were really civil privileges leaders. Do you overstand what I am saying to you my dear brothers and sisters? Your civil rights leaders were really civil privileges leaders.

Now, this is not an emotional conclusion that has its inception in ignorance or jealousy. To the contrary, this is a legal conviction that I have arrived at in light of my re-evaluation of the term civil based on its legal definition. Does this make sense to you? I pray that this definitely does.

What makes your civil rights leaders truly civil privilege leaders was because they were not up to speed with the element of commerce and how it has transmigrated into the common customs of several of the world's cultures. As a people with no culture to make modifications to, we were lost in the mire of oppression and in turn the only thing we really demanded was social change.

Every time someone persecutes us there is a corresponding fee as they are violating your civil rights. Now, the biggest problem with this matter is the fact that you have not defined who or what are you in terms of your legal disposition (*status*) as a people. Listen to me carefully, when one's civil rights are violated there is a corresponding fee to the crime that represents the compensation of the victims. Our leaders fought for social change and in turn we were short changed. Civil rights is more monetary relevant than it is anything else. Are you walking with me?

I really pray that you are.

Now, allow us to take a look at what exactly I am talking about. You need to overstand that other groups of people have built capital on the hardships that you have undergone. Your suffering has in fact been monetized.

At the point when you are charged for a crime this becomes a civil matter. When you hold someone accountable for a crime perpetrated against you and it represents some form of malice or discrimination because of who or what you are; there are specific codes and statutes that represent your monetary compensation so that the guilty and the likes are more reluctant to pursue you in the same matter in the future.

Black people fight for privileges when things go wrong and other races sue. You need to Kill your Oppressor with paperwork and hurt them in their pockets. This is why I am teaching people how to conduct their own lawsuits (read *Kill Them with Paperwork* by Nysut: *Amun-Re Sen Atum-Re*).

Trust me. I am your *Civil Rights* leader. For every count made against the convicted, each one represents a specific amount and if you just want to see justice in the form of the social condition of the guilty changing then these malevolent beings will break up your money amongst each other and laugh as you demand privileges such as vague respect. ***Civil Rights money, funds nations. According to **42 USC – Civil Action for deprivation of Rights**

“Every person who, under color of any statute, ordinance, regulation, custom, or usage, of any State or Territory or the District of Columbia, subjects, or causes to be subjected, any citizen of the United States or other person within the jurisdiction thereof to the deprivation of any rights, privileges, or immunities secured by the Constitution and laws, shall be liable to the party injured in an action at law, suit in equity, or other proper proceeding for redress, except that in any action brought against a judicial officer for an act or omission taken in such officer’s judicial capacity, injunctive relief shall not be granted unless a declaratory decree was violated or declaratory relief was unavailable. For the purposes of this section, any Act of Congress applicable exclusively to the District of Columbia shall be considered to be a statute of the District of Columbia.”

As a people suffering from so many foreclosures through the illegal practices of the banking system more especially in the case of **BofA** or **Bank of America** we need to beseech injunctive relief that is reflective of the restitution of ‘Black’ people’s homes that have been taken from under **conditional interest**.

We need to identify the exploitation that is taking place on account to our race. We need to identify the racial animus. Do you understand what I am saying to you? I really pray that you do.

Listen to me! The best way to start is to begin.

Organize with us and confirm your legal disposition. As a body of people we can truly have a huge impact on this world. Do you understand what I am saying to you? I really do pray that you do.

Now, allow us to home in on some very key elements as found in the legal definition of the word race.

Race - A tribe, people, or nation, belonging or supposed to belong to the same stock or lineage. "Race, color, or *previous condition of servitude*." Const U. S., Am. XV.

Notice the word Nation is used to define race. Hence, the necessity of having a Nationality. Please note that Nationality is not necessarily a designation for lineage. Stock denotes a specific group or type of people. Here is a very important part of being a race; being able to define historically, whether most recent or ancient your people's previous condition of servitude. The trick to this is that the people have to agree on what their historical disposition is in respect to how it has changed or been altered present day. The goal is to live in conformity to one's culture. Once this has been accomplished we can consider restitutio in integrum.

Ultimately, Race is a Legal Determination and in order for a people to qualify as a race they must know how to identify their condition.

Now, what is the legal interpretation of Condition?

According to the Black's Law Dictionary,

Condition-

In the civil law. The rank, situation, or degree of a particular person in some one of the different orders of society. An agreement or stipulation in regard to some uncertain future event, not of the essential nature of the transaction, but annexed to it by the parties, providing for a change or modification of their legal relations upon its occurrence. Mackeld. Rom. Law,

As you can clearly see, the word condition takes on a historically relevant connotation as well as a present day context. A **Race** must be able to identify their condition. Legally, your condition identifies your past and your endeavor to recapture the same disposition or maintain it in the future in respect to your present.

Our people have yet to agree on what their history is. Are you walking with me? In order for us to qualify as a race, we must be able to identify when we were in our pristine state as a people to determine how far we have deviated, in order to effectively plan for the future.

Culture represents the forward momentum of a specific group of people. Culture has several designations that will ensure that the people that confide in it most will be subject to the least adverse affects of their *decision- making*.

Culture represents the forward momentum of a specific group of people. A people without goals will be more prone and susceptible to their lower nature than any other animal on this planet.

A **Race**, by law has to identify where they were in history and how far has modern society caused them to deviate from the same. In turn, goals are set by the **Race** (*modifications in their culture*), to provide for a better future predicated upon the way things used to be in respect to the civil practice of the perspective time they are functioning in.

The *'Jewish'* community as well as the homosexual community has qualified themselves as a race. Though, one is a religion and the other is a sexual preference, the aforementioned groups have been able to accomplish what the **'Black Group'** has failed to do and that is substantiate their **rank** by identifying their *previous condition of servitude* in order that they may qualify as a race. Your school system, religious institutions and the prison system have been greatly compromised on account to the fact that we are low on resources in this country at great length and the national debt each day becomes the largest growing phenomena of this world in which we live.

This exploitation must come to a complete end and the only way that it will, is if you learn how to take things unto the next level. Now is not the time for complaining. As a people we have done entirely too much of this. Are you walking with me on this matter? I pray that you are.

Now, I would like for you to continue walking with me on these matters for you are about to embark upon a journey like none have ever before. I am really appreciative of the opportunity that you have given to me to connect with you. It is truly that great day in time that our ancestors have appraised throughout their scriptures. This is not the point in time in which we should be living in a state of fear. Do you overstand what I am saying to you? Embrace your destiny.

Now, I would like for you to take a look at some of the stipulations as found in the 501(c)(3) construct

The 501(c)(3) corporation:

- * may exist in perpetuity;
- * is required by law to serve the State;
- * must support the government agenda, i.e. all public policy;
- * is not really tax exempt, since it pays Social Security taxes;
- * allegedly has limited liability protection;
- * is considered just another business;
- * can hold real estate;
- * can sue and be sued;
- * members do not own any of the assets;

- *The creator of a corporation is the State;
- *The State is the sole authority and sovereign head over the corporation;
- *The corporation is subject to the laws of the State which limits its powers;
- *The corporation has no constitutionally protected rights;
- *The corporation is an artificial person;
- *The corporation submits to a State Charter declaring it is a creature of the State;
- *The corporation is created for the benefit of the public;
- *The corporation is a State franchise;
- *The corporation is a privilege granted by the State.

Now, the question at hand that we must ask ourselves is this. Why are churches petitioning to become **501(c)3** organizations. Why are churches incorporating when they really do not have to since THE UNITED STATES... and the United States...do not have any jurisdiction over churches?

As a matter of fact **Senator Lyndon B. Johnson** wanted to eliminate the influence of Churches in fear that the religious institutions' convictions would conflict with the government. Senator Lyndon B. Johnson saw to it that Churches would apply for **501(c)3** tax exemption status.

Now, the reality is this, members of the church did not understand the law so they were convinced that Lyndon B. Johnson was doing them a serious favor by setting up a program for the churches to become tax exempt.

Now, the reality is this. According to **IRS code 508(c)(1)(A)** – ‘*Mandatory Exception*’ rule.

Special rules with respect to section **501c3** organizations. (a) New organizations must notify secretary that they are

applying for recognition of section 105c3 status. (c) Exceptions

(1) Mandatory exceptions. Subsections (a) and (b) shall not apply to –

(A) churches, their integrated auxiliaries, and conventions or associations of churches.

As for tax deductions, Churches already have a tax- deductible disposition according to **IRS publication 526**. Do you overstand what I am saying to you? I pray that you do.

Now, the reason that I am pointing these things out is so that you may overstand the fact that Churches do not have to petition to be **501(c)3** corporations but they still choose to of their own free will and accord. Now if you do not know what the big deal is, allow me to outline a few points.

The Church is supposed to be erected for God and of God in order that God’s word may be propagated.

The 501(c)3 status contradicts the Churches’ mission...

In terms of the **501(c)3** 1.The creator of the Corporation is the state 2.The state is the sole authority and sovereign over the corporation 3. The corporation has no constitutionally protected rights

4. May exist in perpetuity (*must surrender their assets if the ones responsible for the corporation choose to dissolve corporation*)

5. *Must support government agenda*

Do you overstand what I am pointing out to you? The Churches must corroborate the government agenda even if the agenda contradicts the church’s belief system so that they will not lose their tax benefits. This is a prime exemplification of In *Equity or Iniquity*.

Now couple this data off with the reality that prisons are being privatized so that investors can make a profit off of incarcerations (read *Real Estate or Legal Fiction* by *Nysut: Amun-Re Sen Atum-Re*).

In addition to this matter, I need for you to also consider the fact that THE UNITED STATES IS A CORPORATION and this corporation is in control of the schools teaching your children how to be employees instead of employers (*The Abolition of the Board of Education Act*). In addition to this matter since property taxes fund schools and lower income communities have a very high foreclosure rate the schools impacted the most have been compromised at great length because the only other funds that they will receive of significance is from the **No Child**

Left Behind Act. According to this Act, schools will receive funding so long as children are simply passed (graduate). This has caused schools to lower their criteria of education so that the curriculum will be easy enough for children to graduate to receive their funding.
