**Notice of Understanding & Intent and Claim of Right
Notice to the UK Government Appointed Executive Agency – DVLA**

25th November 2009

Notice of Understandings

I, Paul of the family Haley, having served notice to you that I can no longer lawfully pay any form of tax to HM Government or its executive agencies, due to its alleged illegal acts and crimes of war, now wish to act in honour by giving you appropriate notice of my understandings, intentions and claims of right as related to my private conveyance and accordingly I hereby do solemnly and sincerely declare that whereas it is my understanding that;

any right that you, the DVLA, may claim over my private conveyance (car), known to you as a 'motor vehicle' by your Registration Mark "N971 KPW", can only be upheld through my consent and;

that any statute which you may claim to use to back any such claim over my car can only be valid if I consent to be bound by those statutes and;

that my purchase of my car - which is my own private conveyance and is not used in commerce (commerce; defined as the buying and selling of goods/services) for financial gain - my possession, upkeep and maintenance of it proves that I am the lawful owner and have sole inalienable claim over/to it and;

that any claim that you have over myself to control whatever form of private conveyance I may choose to operate on the roads and highways of this land is only done with my consent and;

that any statute which you may claim to use to back any such claim you may make to control whatever form of private conveyance I may choose to operate on the roads and highways of this land is only lawful when done with my consent and;

that I understand that I do not have to consent to be bound by any such statutes as I am withdrawing the registration of my 'person', under separate cover to the Secretary of State, in order to become a freeman on the land and seas of planet earth, but that in any case I cannot continue to give my consent to be bound by statutes for the reasons of law and conscience, as explained in the relevant notice (enclosed) and;

that, according to Part I, 1.(1) of the statute entitled "Vehicle Excise and Registration Act 1994", which I presume you stand under, "... *A duty of excise ("vehicle excise duty") shall be charged in respect of every mechanically propelled vehicle which is used, or kept, on a public road in the United Kingdom and shall be paid on a licence to be taken out by the **person** keeping the vehicle...*" but;

that I now understand the term 'person', as far as statutes which use legalese are concerned, means a legal fiction and not a human being and;

that as a Freeman on the land and seas of planet earth I am a human being born free under common law and not such a defined 'person' and therefore am not bound by the above mentioned statute and;

that therefore, the duty of excise you have to date levied against my private conveyance has been done without full disclosure of the meaning of the terms in the related (or for that matter any other) statute and;

that I now understand that as I am not a 'person' I do not need to take out a licence to travel in my own private conveyance and;

that this understanding is further evidenced and supported by a licence being defined by the Collins English Dictionary as "*a document giving official permission to do, use or own something...*" and therefore cannot reasonably apply in any case, as I cannot need any third party permission to use or

own my own private conveyance, so long as I do not contravene the common law in its use or intend to charge a fee to others for carriage within it as passengers, such as a taxi or other commercially operating driver would do (both of which underlined terms are terms used in commerce and do not apply to me or my car) and because I understand that I have the right to travel freely on the land under common law (i.e. so long as I do not cause my fellow man injury or harm, loss or damage to his property or act fraudulently against him) and;

that I understand that it is my responsibility as a law abiding freeman under common law to ensure that my private conveyance is road worthy and safe to drive on the roads and highways with assurance so as not to put my fellow man at risk of injury, harm, loss or damage and;

that I do solemnly declare that as such a responsible Freeman I have ensured that the above applies to any and all private conveyances that I may own or in any other way lawfully use.

Notice of Intent

Based on the above stated understandings I hereby give notice that any consent, which may have been either expressed or implied by myself (without, I would suggest, full disclosure on your part) in regard to or in relation to any statute, such as that referred to above, regulating the operation of any form of conveyance on roads and highways, is withdrawn with immediate effect.

And, furthermore I hereby give notice that all and any registrations with DVLA, in the name of Mr. P. Haley, Mr. PAUL HALEY or any other such similarly titled legal fiction (which relates only to the 'Person' created by the registration of my birth – the details of my birth itself being merely here-say - without my consent, and for which I can merely act as agent in correspondence in the short term, until these related notices come into affect) are now void.

Claims of Right

I hereby serve notice and state clearly, specifically and unequivocally that under the common law and customs of England, (which HM Queen Elizabeth II has sworn oath to protect), I reclaim all that which is rightly, justly and lawfully mine from HM Government and all its agents.

I claim full lawful rights, allodial title to and ownership of any form of safe and roadworthy (as described above) private conveyances in my lawful possession and the use of them freely on roads and highways, or on private land, acting with reasonable care and responsibility to third party road users, so long as I am not acting in commerce as stated and defined above.

I also claim my lawful right to travel as defined above without let, hindrance, levy, licence or duty.

I further claim the right to put reference mark plates on my private conveyance in a size, style, colour and lettering of my own choosing, but such that they are displayed in a clear and identifiable fashion so that any interested relevant party can refer to the exact status of myself and my private conveyances. A further notice will be sent to you informing you of this reference mark, once it has been displayed, for your records.

And, I claim the right to use or accept the use of any word, term or words used to describe a private conveyance being owned or used by myself, or to describe its operation, which may include but will not be limited to such terms as; 'vehicle', 'motor vehicle', 'driving', 'driver', 'car', 'automobile', or any words used in relation to such private conveyance, and that this use or acceptance of use will not in any way imply consent to be bound by any statute.

Fee Schedule

In addition to the above stated claims, I claim my right to use my own Fee Schedule and give notice that this Fee Schedule will apply in regard to my lawful right to travel freely on our roads and highways as far as any transgressions by The State, (as defined in my related notice) including police (men or officers), government (principals or agents) or civil servants (e.g. those in the so called 'justice system') may be concerned and that my fees stated on this schedule for any such transgressions against my freedom are as follows:

Being Restricted

If stopped and from the moment of being so stopped (with the exception of being stopped by such an officer who has lawful just cause e.g. is seeking to protect me from harm or intends to arrest me for a common law offence i.e. where I have caused my fellow man injury or harm, loss or damage or have acted fraudulently against him), questioned, interrogated or in any way detained, harassed or otherwise regulated,

Five Hundred Pounds Sterling/Hour

Unlawful Arrest

If arrested under anything other than a common law offence, and from the moment of any such arrest, handcuffing, transportation, incarceration or subjection to any adjudication process without my express written and notarised consent,

Five Thousand Pounds Sterling/Hour

Common Law Crimes

If any form of force is used against either myself or those under my care and protection whilst travelling as my private guests, whether or not but especially where it results in injury or harm to myself or such guests, damage or loss to our property, such as my privately owned, borrowed or hired private conveyance,

Fifty Thousand Pounds Sterling
(in addition to any compensation that may be awarded)

Dealing With Unlawful Actions

I further claim the right to convene a proper common law court de jure in order to address any potentially criminal actions by any representatives of 'The State' (as previously defined) who, having been served notice of this claim, fail to dispute, discuss or make lawful counterclaim, and who then, either by act or omission, interfere with the lawful exercise of those properly claimed and established rights and freedoms.

Lastly, I claim the right to deal with any counterclaims or disputes publicly and in an open forum using discussion and negotiation and to capture both video and audio evidence of any such discussion and negotiation for my lawful purpose.

Notice Period for Responses

Affected parties wishing to dispute the claims made herein or make their own counterclaims, have 14 (fourteen) days from the registered receipt of this notice in which to do so.

Any such response is required to be made by an appropriately authorised and suitably empowered representative of the relevant organisation, under their full and binding oath or attestation, and under their full commercial liability and penalty of perjury, and sent correctly addressed, as previously advised, to myself, via registered mail, such that it is received within the notice period given above.

Failure to register such appropriate dispute or counterclaim will be taken to mean that all the affected parties, including DVLA, tacitly agree with my understandings, intentions and claims, evidenced by their acquiescence, and will be regarded as a permanent and irrevocable estoppel by acquiescence, barring any claims and/or the bringing of charges by yourselves, or any other interested third parties or representatives of 'The State', under any statute, against myself for exercising my lawful and properly established rights and freedoms, so that I may remain within the law and act with integrity according to my moral conscience and its associated ethics.
